### ELECTION NOTIFICATION & NOTIFICATION OF AGM

To all London & South East Region members,

The Constitution requires that a Regional Committee be elected. The current Regional Committee therefore propose to make the following arrangements for the election of the Regional Committee. The Regional Committee will comprise a Chairperson, Secretary, Treasurer, Regional Convenor and not more than 2 elected members. In accordance with the constitution, every member of the current Regional Committee must retire but may be re-elected.

As with the Executive Committee of the whole Society, an election, if necessary, will take place by electronic ballot with the results of that ballot being announced and approval of the election result sought at the next Annual General Meeting of the London Branch which is scheduled to be held on Tuesday 11 October 2011.

Please note that this year a vacancy exists for the role of Regional Convenor, as Jonathan Cope has decided to step down from this role.

In order to achieve this, the Regional Committee has agreed to the following timetable:

Nominations of fully paid up members of the Society, indicating the post/membership sought, to be confirmed in writing by the candidate together with a written indication of support from two fully paid up members of the Region acting as proposer and seconder, to be received by Jeremy Glover ([jglover@fenwickelliott.com](mailto:jglover@fenwickelliott.com)) no later than 1700 hours on Friday 16 September 2011.

Should an election be necessary for any post or general member of the Regional Committee:

- (i) Those fully paid up members of the Society properly nominated will be invited to provide a written election statement of no more than 100 words to Jeremy Glover ([jglover@fenwickelliott.com](mailto:jglover@fenwickelliott.com)) by 5pm on Monday 19 September 2011. Those statements will be issued to fully paid up London & South East members of the Society;
- (ii) The electronic voting facility will be available to fully paid up London & South East members of the Society on the Society's website from Tuesday 20 September 2011;
- (iii) The election will close at 1700 hours on Friday 7 October 2011. Martin Potter and John Burgess will act as the returning officers.

The election result will be announced at the Region's Annual General Meeting on Tuesday 11 October 2011 at Berrymans Lace Mawer, Salisbury House, London Wall, London EC2M 5QN and ratification of the result sought from that meeting.

The new Regional Committee will take up its role from the conclusion of the Annual General Meeting.
